## **ST. MICHAEL'S BRANCH** **DATA PROTECTION POLICY**

Unlike the main RAF Police Association, & its other Branches, the St. Michael's Branch has no legal obligation to comply with either the United Kingdom Data Protection Act or the European Union (E.U.) as our data is held outside of the United Kingdom/E.U. We therefore apply the legislation of the Country in which the data is held, it being the country of residence of the Branch Secretary which for the time being is the Republic of South Africa.

The legislation & principles applied are in accordance with the Protection of Personal Information Act (POPI) which was signed into law by the State President in November 2013 with sections of the Act being gradually introduced from April 2014; the POPI is almost identical to the U.K. & E.U. Data Protection Legislation, it differs only in that it is not yet extended to data held on the 'Web' or 'Cloud'. In accordance with the Act, the Branch Secretary has been appointed as the 'Information Officer'.

The only data retained by the Branch in respect of its members is that necessary for the smooth running of the Branch and is contained within a password protected MS Access Database lodged on the home computer (also password protected) of the Branch Secretary.

Housed within the password protected area of the Branch Website (<http://st-mike.com>) is a copy of the Branch Profiles & Roll, which also doubles as the Branch E-Mail Directory, and is produced from the above mentioned Database; members are afforded access to this document.
